3. CONSTRUCTION

3.1 Authorization to Transfer and Expend Funds From the Inyo-Kern Schools Financing Authority to the Sierra Sands Unified School District General Fund for the Purpose of Completing the Las Flores Elementary School Modernization Project

<u>BACKGROUND INFORMATION</u>: The district is currently preparing the Las Flores Elementary School campus for the scheduled return of the student body, faculty and staff on August 1, 2012. Under a Lease, Lease–Back contract, Balfour Beatty completed an electrical upgrade, installed six (6) new relocatable classrooms and a relocatable restroom and performed a variety of hardscape replacement work, including two new fire lanes.

A companion agenda item (SSUSD item 10.2) requests authorization for the purchase of two replacement kindergarten classrooms.

<u>CURRENT CONSIDERATIONS:</u> To complete the Las Flores modernization project, a variety of miscellaneous jobs will be required. Although the list below is currently accurate, additional items may surface as the work is being completed. Costs represent best estimates:

<u>SUPERINTENDENT'S RECOMMENDATION</u>: It is recommended that the board authorize the fund transfer and expenditure as delineated above, to complete the Las Flores modernization project.

4. EDUCATIONAL ADMINISTRATION

4.1 Authorization to Transfer and Expend Funds From the Inyo-Kern Schools Financing Authority to the Sierra Sands Unified School District General Fund for the Purpose of Purchasing English Language Arts, Transitional Kindergarten and ROP Construction Textbooks and Instructional Materials

<u>BACKGROUND INFORMATION</u>: A recommendation to adopt English Language Arts materials for grades K-5 was presented to the board in April 2011. The board approved this recommendation and implementation began in the fall of 2011. It was then recommended the district continue the review and adoption process for English Language Arts materials for grades 6-8 in 2011-12.

<u>CURRENT CONSIDERATIONS:</u> Sierra Sands began reviewing instructional materials for English Language Arts adoption as well as instructional materials for Transitional Kindergarten and ROP Construction. A recommendation is being presented to the Sierra Sands Unified School District Board of Education tonight for approval. The anticipated cost for all of these textbooks and instructional materials is \$195,121.03.

<u>SUPERINTENDENT'S RECOMMENDATION</u>: It is recommended that the board authorize the fund transfer and expenditure in the amount of \$195,121.03, for the purchase of textbooks and instructional materials as presented.

5. GENERAL ADMINISTRATION

5.1 Adoption of Board of Directors Calendar for the 2012-13 School Year

BACKGROUND INFORMATION: Resolution # 90/91-2 dated December 3, 1990 designated the regular meeting of the Board of Directors of the Inyo-Kern Schools Financing Authority to be held on the second Thursday of December each year, beginning in 1991. These meetings ran concurrently with the organizational meeting of the Sierra Sands Unified School District held in December of each calendar year. On August 19, 2010, due to new legislation stating that all transactions occurring after January 1, 2010 must be acted upon during a regular scheduled board meeting, the board of directors approved a regularly scheduled meeting calendar to coincide with the regular meeting calendar of the Sierra Sands Unified School District.

<u>CURRENT CONSIDERATIONS</u>: It is recommended that regular board meetings for Inyo-Kern Schools Financing Authority for the 2012-13 school year be conducted on the same schedule as the regular scheduled board meetings of the Sierra Sands Unified School District board of education on the following dates:
